(e) Compensatory Arrangements with Certain Officers.

On March 13, 2019, the Compensation Committee of the Board of Directors of Healthcare Trust of America, Inc. (the “Company”) recommended, and the Company’s Board of Directors approved, an extension of the term of the Company’s employment agreements (the “Employment Agreements”) with each of Scott D. Peters, the Company’s Chief Executive Officer, President and Chairman, Robert A. Milligan, the Company’s Chief Financial Officer, Secretary and Treasurer, and Amanda L. Houghton, the Company’s Executive Vice President - Asset Management, pursuant to a letter agreement with each executive dated March 18, 2019 (the “Letter Agreements”), such that the terms of Messrs. 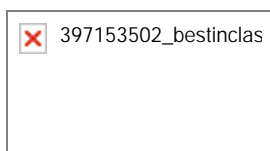

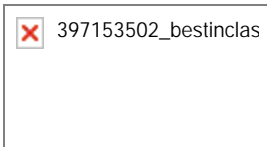

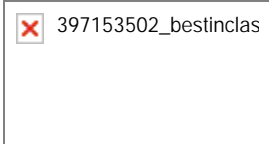
